On the basis of your requisition and self-declaration I send the recognition from First Class to Eighth class to the Lala Deep Chand Jain Public School, Village Mehmampur, S.A.S. Nagar.

The above recognition is based on the following terms and conditions that:-

1) It will be the personal responsibility of the school administration that as per the limitation given the building Safety Certificate and Fire Safety Certificate be deposited in this office. In case of negligence the process of cancellation of recognition of your school will be started.

2) The sanction of the recognition is not liable to be increased and in no case the recognition/affiliation is applicable beyond eighth class.

3) The above recognition is based on the self declaration given by you if any of the clause given in the self declaration is found to be wrong or false then the proceedings will be initiated to cancel this recognition.

- 4) The school is being run by the society registered under the 'Society Registration Act, 1860 (Act No. 21, 1960) and by the trust established by any law applicable from time to time.
- 5) The fresh registration of the society, if necessary, will be assured.
- 6) The school is not being run by any person, community or person-communities or for personal gain of any other person.
- 7) The account of the school will be audited and proved by some chartered-accountant and requisite statements of the accounts will be prepared as per rules.
- 8) In the first class of the school 25 % of the total number of the children will be admitted from the weaker sections and Facility less groups and will provide free and compulsory education until it is completed. If the school provides pre-primary education then the same terms will be applicable.
- 9) For the children shown in Para No. 7, as per the Sub-Clause 2 of the Section 12 of the Act the expenses of the school will be paid. To get this aid-payment the school will have to keep a separate bank-account.
- 10) The school will not charge any capitation fees and the child or his/her parents or his/her guardian will not be put to any retrenchment process.
- 11) The school will not refuse admission to any child on the following reasons:-

- a) A child not having age proof.
- b) Any child demanding admission in extended period or beyond the extended period.
- c) Religion, caste, creed or place of birth or any of these reasons.

The school will ensure that:-

- a) No admitted child will be kept in the class or he will not be expelled from the school before the completion of the Elementary Education.
- b) No child will be made a part of corporal punishment or mental harassment.
- c) Till the completion of the Elementary Education the child will not be required to pass any Examination of the Board.
- d) Every child completing the Elementary Education will be given a Certificate under Rule 21.

- e) As per the Sub clauses of the Act the handicapped/children requiring special needs will be joined/given representation .
- f) As per Sub Clause (1) of Section 23 of the Act only the teachers fulfilling the minimum Educational qualifications will be appointed.
- g) The teachers will not make themselves busy/involve in any private teaching process.
- 13) The school will adopt the syllabus on the basis of prescribed subjects by the competent authority.
- 14) The school will abide by the terms and conditions under Section 19 of the School Act.
- 15) In the name of the school , no non-recognized/non-sanctioned classes will be run inside or outside the building of the school.
- 16) The school building or other structure or ground will only be used for education and personality development.
- 17) The school will make available the requisite information and knowledge to the Director School Education and Distt. Education Officer from time to time and in order to keep intact the recognition of the school will abide by the instructions issued by the State Govt. Local Authority in order to remove the deficiencies of the running of school or it will abide by requisite/issued terms .
